

Wedding Packages Terms and Conditions

Please read carefully the following notice as it is your contract with Terrasenses & ETICA Events:

Payment:

- You will need to return a signed copy of the contract or letter of agreement with a 30% deposit of the total fee.
- 50% of the total fee is required within 120 days prior to the event (whichever is the greater).
- The remainder of the total balance must be paid 183 days prior to the event
- No services from Terrasenses and ETICA Events or its suppliers will be guaranteed unless payment is received.

Cancellation policy:

For cancellations by Guests, cancellation charges depend on when Terrasenses & ETICA Events receive notice of the cancellation. Should the client wish to cancel, cancellation charges will be imposed. They are calculated from the day written or verbal notification is received by the company as a percentage of the total package price per person including surcharges. The cancellation charges shown as below are those which will apply to our Wedding Destination packages and a-la-carte weddings:

- 30% is a non-refundable deposit.

Terrasenses & ETICA Events require a non refundable deposit on all the wedding packages in order to secure your wedding reservation. Final payment & remaining balance is to be made 183 days prior to your wedding date. All users accessing Terrasenses Online & making booking reservations for wedding packages are bound to accept these non refundable deposit terms & conditions.

- If notice is received 55 and more days prior to Arrival, 50% of the purchase price
- 55 to 28 days prior to arrival 70 %.
- 27 to 14 days prior to arrival 90 %.
- If notice is received less than 14 to 0 days prior to Arrival, 100% of the purchase price.
- No refunds or adjustments will be made for any portion of your vacation or attendant services not utilized.

Changes to Reservations

If Guests desire to change, but not cancel, a reservation, Guests must notify Terrasenses at least 90 to 60 days prior to Guest's originally scheduled Arrival. An administration fee of \$ 35 per booking plus any additional costs or charges incurred by us or by our suppliers. All requested changes to reservations are subject to Terrasenses and ETICA Events' sole discretion, and any changes must be approved in writing.

Pricing:

If you chose to have a tailor made event, the pricing policy for Etica Events has been set up as such to ensure you have visibility of your wedding costs throughout the project. We will work within the budget you have defined. If any extras are required then these will be carried out with your consent in writing.
